Invasive alien species occur in many national parks and historic sites. They can impact ecological integrity, species at risk, infrastructure, cultural resources, recreation, as well as the safety and health of visitors and staff.

Parks Canada manages those species by preventing their introduction and spread into protected heritage areas, detecting them as early as possible, and reducing their populations to mitigate their impact.


